QA Dimension (D2)

By strengthening the international dimension of Quality Assurance from a Mediterranean perspective working together with MED universities and EU QA agencies

- Exploring shared definition of harmonised QA criteria /standards as a way to fostrer international cooperation and facilitate the building of HE areas
- Favouring students and graduates' mobility and employability

Quality Assurance



NB: The purpose was NOT to promote the creation of QA agencies in countries where it did not exist BUT to contribute to the enhancement of QA mechanisms at the internal level of HEI and at the external level with regard to the evaluation procedures defined in the area







What is the relevance of QA in HE and the potential benefit for the area?





Current situation



- Radical change in HEI: quality, enhancement and excellence are essential elements of modernization of HE systems
- Societies are increasingly knowledge-based,
 HE is more and more important for the progress of both individuals and countries
- Massification of institutions creates a demand for more transparency and public accountability





Current Situation



Therefore:

HEIs need to signal the quality of their research and teaching

&

➤ Identify either references for quality or technical support or resources to set up a QA system





Role of QA for...



- Internationalisation: should be the basis of transparency and mutual trust for a greater comparability, better recognition and improve mobility
- Employability: by promoting the embedding of employability into the curriculum, adpating them to the local or global employment contexts, introducing new degree porposals...





Conclusions



- The building of QA system for HEI in the Euro-MED area is a long process including several steps:
- a) establish a set of common criteria defining the internal quality assurance of universitie using the EU experience and incorporating the academic needs/requirements of the partners
- b) developping ways of cooperation in the region by promoting dialogue among existing regional network





Conclusion



- Importance to have approval of ministries of education and/or official recognition bodies
- Main goal is to enhance HEI quality by: focusing on continual improvement and effectiveness and not fulfilling a specific standard
- QA should be a mean, not an end in itself: a "vehicle to facilitate universities tasks in an internationalized context"


